California Proposition 65

Proposition 65 (or Prop 65), officially known as the [Safe Drinking Water and Toxic Enforcement Act of 1986](#), was enacted as a ballot initiative in California (USA) in November 1986. Prop 65 is intended to enable Californians to make informed decisions about their exposures to chemicals in products they purchase, in their homes or workplaces and in the environment largely by requiring businesses to provide warnings about significant exposures to designated chemicals. Proposition 65 requires the state of California to maintain [a list of chemicals known to the State to cause cancer or reproductive toxicity](#). The Office of Environmental Health Hazard Assessment (OEHHA) administers the Prop 65 program (further information on [Proposition 65 - OEHHA \(ca.gov\)](#)). This list, which is updated at least once a year, has grown to include over 900 chemicals since it was first published in 1987. Prop 65 requires adequate warning labels to be provided on products containing any of the chemicals from the previously mentioned list with significant risk of exposure.

TE Connectivity relies on declarations from our suppliers to determine if Prop 65 chemicals are present in our components and raw materials. Utilizing these supplier inputs, TE can, upon customer request, provide a listing of any Prop 65 chemicals present in our products. Please contact productcompliance@te.com.

While our products may be available for sale online or via other sales outlets, our products, when used as intended, should not intentionally release any Prop 65 chemicals. Our experts ensure the safety of TE products with thorough risk of exposure assessments based on material compositions, product structure, or laboratory tests. Whenever TE determines that a product fulfills Prop 65 warning requirements, the appropriate Prop 65 warning is provided. Given the broad range of applications in which TE's products can be used, customers should evaluate the environment in which they intend to deploy or utilize TE products and make their own determination regarding their obligations under Prop 65 to employees, consumers or other individuals in California.

As the global leader in connectivity and sensor solutions, TE Connectivity routinely makes acquisitions and divestitures to build and optimize our offerings for our customers. As a result, integration and divestment activities are a normal part of our operations.
